Notice of Standards Change

Effective 10/1/2010: The BACB will no longer accept non-university coursework or applications under the "old" experience standards. All applications for examination using non-university approved coursework or "old" experience must be received before 10/01/10, and be complete when received.

Renewal and Recertification

You may have noticed at bacb.com that the BACB opened a 90-day window for 2008 and 2009 renewals that extended through August 10, 2009. If you did not avail yourself of the opportunity to renew or recertify during this window, you will need to apply under the Reentry Standards that follow.

Re-Entry is Available to Most Former Certificants No Retake of Examination Necessary

Reentry may be available to you – At the May 2009 Annual Meeting, the BACB Board of Directors approved an expansion of the reentry policy. Whether you qualify for reentry will depend on the expiration date of your certification cycle -- this is the date that was printed on your most recent certificate. Please note that all certificants

due to recertify prior to 2005 were given an extension to 2005 or later. If you know you were certified prior to 2005 but do not know the date of expiration, use the 2005 date as your date of expiration. Reentry is available to 2005 expirations up through 12/31/2010.

In order to reenter, you do not need to re-apply and meet the BACB's eligibility requirements; instead, you must:

1. Pay the reentry fees identified below at the time of reentry application; and
2. Complete the continuing education identified in the charts below or sit for and pass the certification examination for your certification level. (Previously certified BCBA's may only sit for the BCBA examination and previously certified BCaBA's may only sit for the BCaBA examination for reentry.) If you apply to sit for the examination for reentry you

must pass the examination for reentry; you may not substitute other types of approved continuing education in lieu of a failed examination.

To calculate the reentry fee due and amount of CE you must complete, use Chart A if you are applying for reentry prior to 12/31/2010 and Chart B if you are applying for reentry prior to 12/31/2011.
