## Summary

[Lightcast](#)<sup>®</sup> is a software company that collects and analyzes labor market data in the United States. These data are aggregated in the [Developer](#)<sup>™</sup> database, which includes online job postings collected from over 65,000 sources. This database allows advanced searches of over 70 data fields that are extracted from each posting, including job title, occupation, employer, industry, required skills, credentials, and salary. Duplicate job postings are excluded from Developer search results.

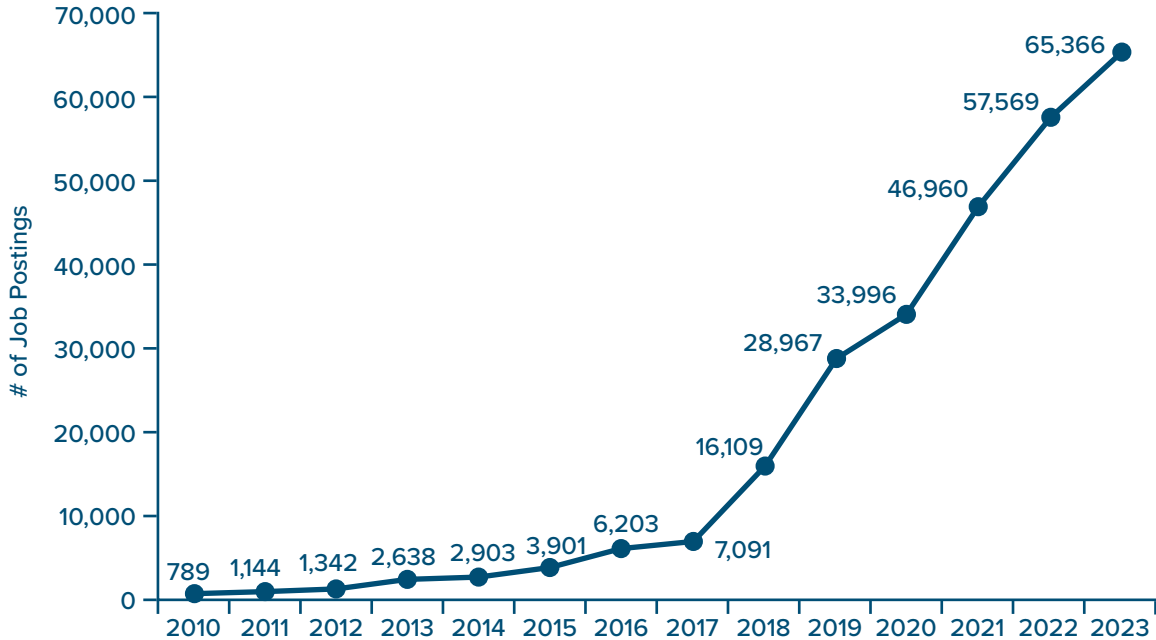
The Developer database was used to assess the national employment demand for behavior analysts from the past 14 years (2010–2023) and the demand by state from the past 12 months.

## Key Findings

- **Demand for behavior analysts is increasing.** Annual nationwide demand for individuals holding BCBA or BCBA-D certification has increased each year since 2010, with a 14% increase from 2022 to 2023. Demand was highest in 5 states in 2023 (ordered from most to least): California, Massachusetts, Texas, Florida, and Georgia. These 5 states account for 40% of the recent demand for behavior analysts, with California alone accounting for 18% of the 2023 demand.
- **The demand for assistant behavior analysts was 3% lower in 2023 compared to 2022, although overall demand still remains high.** Demand was highest in 5 states in 2023 (ordered from most to least): California, Florida, Virginia, Texas, and Michigan. These 5 states account for 52% of the recent demand for assistant behavior analysts, with California alone accounting for 17% of the 2023 demand.

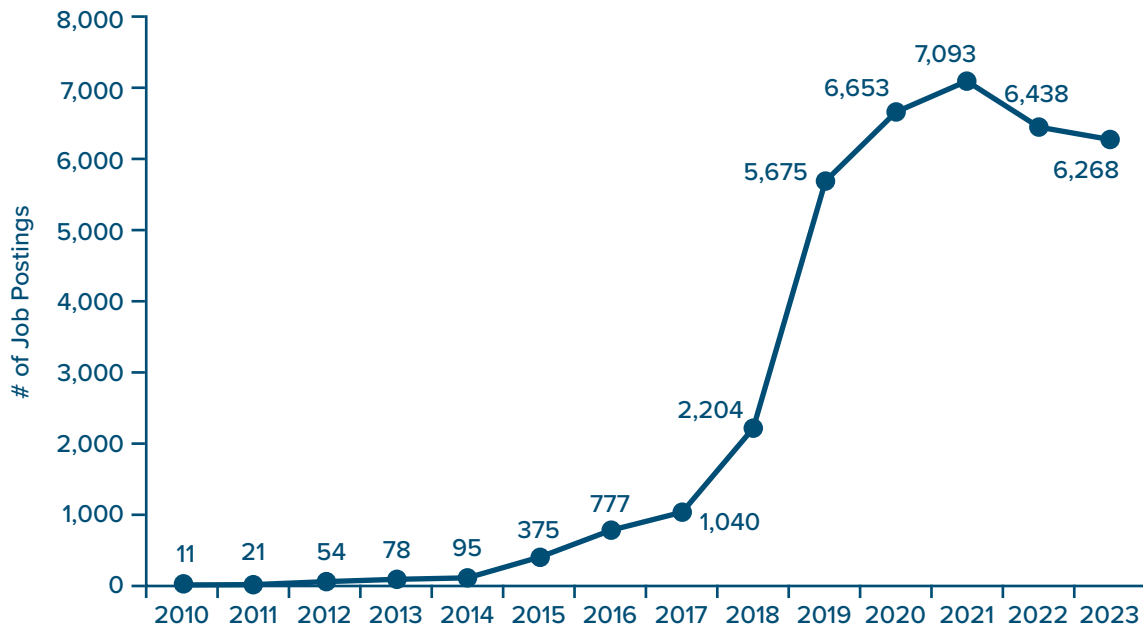
### Annual Demand for BCBA Certification

### Annual Demand for BCaBA Certification

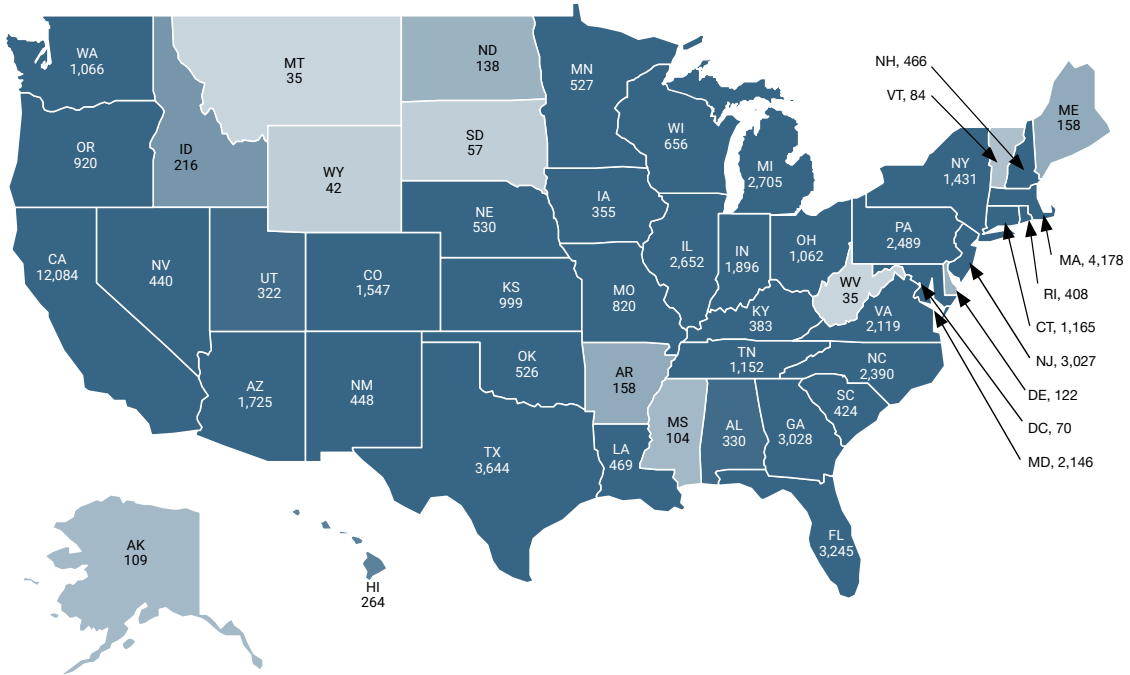
The following graph depicts the annual number of job postings over the past 14 years (2010–2023) that either required or preferred BCaBA certification.



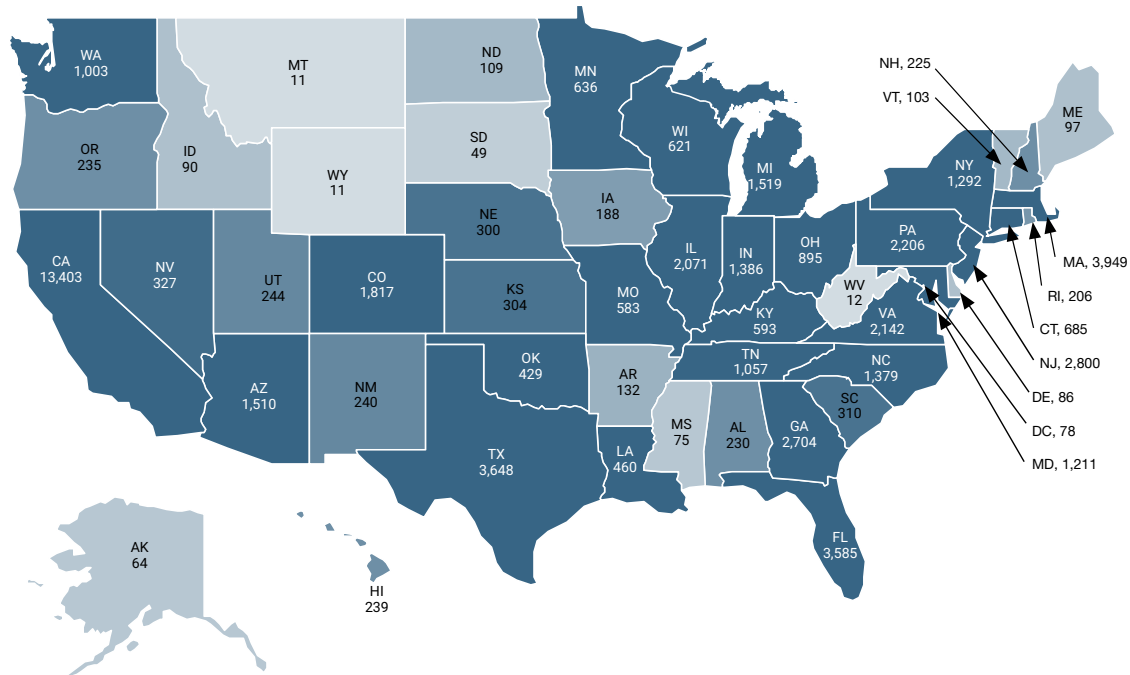
## Demand for BCBA/BCBA-D Certification by State

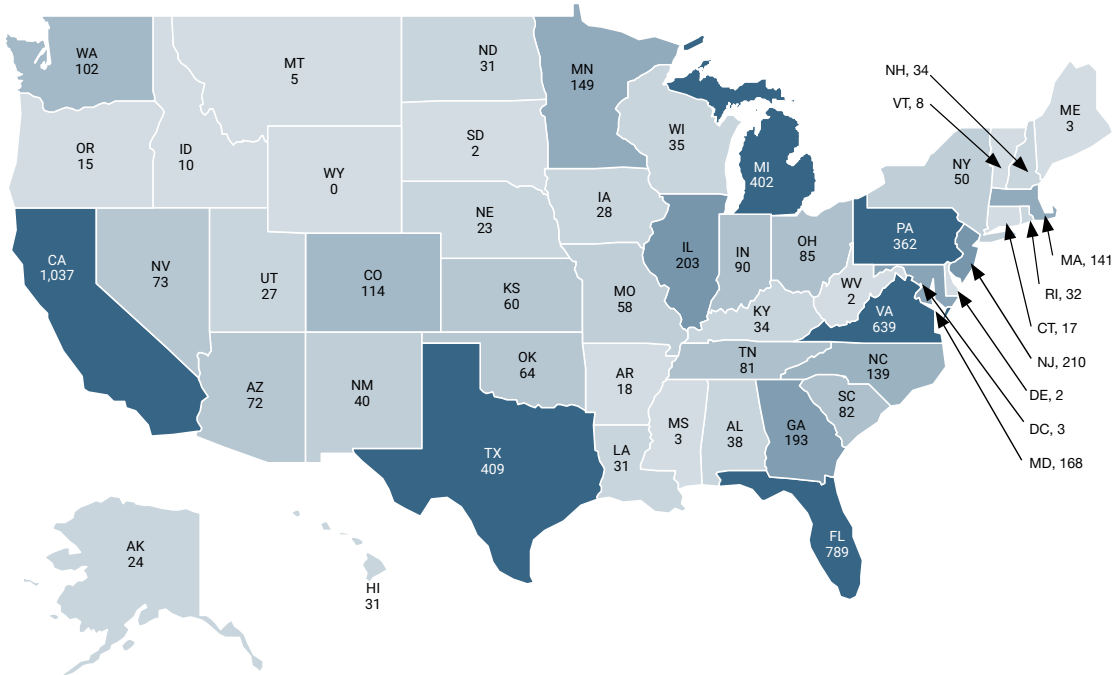

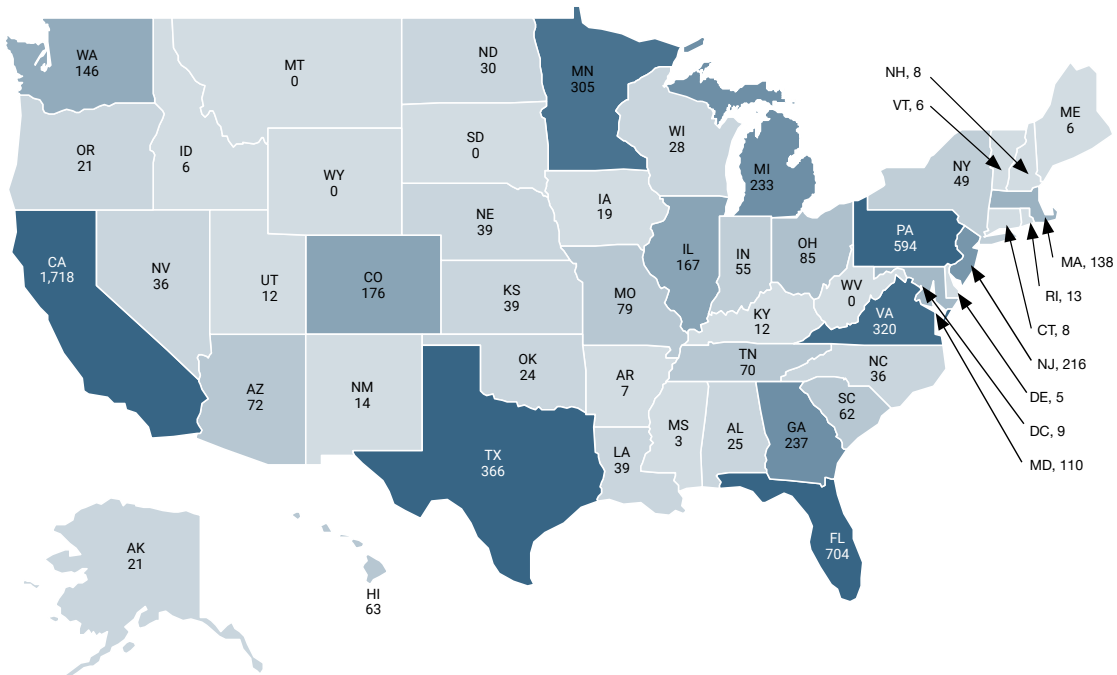
## Demand for BCaBA Certification by State
